ORDINANCE NO. 1259-24

AN ORDINANCE ESTABLISHING AND PROVIDING FOR 2024 COMPENSATION FOR THE MAYOR, PRESIDENT OF COUNCIL, COUNCIL MEMBERS, AND BOARD OF PUBLIC AFFAIRS, AND DECLARING AN EMERGENCY.

BE IT ORDAINED, BY THE COUNCIL of the Village of Rushsylvania, Ohio:

SECTION I: That all Ordinances heretofore passed by the Council of the Village of Rushsylvania, Ohio, providing for compensation for certain Village elected officials be, and the same hereby are, repealed and replaced as follows and the following provisions relating to said elected officials of the Village of Rushsylvania, Ohio, which are unchanged, are hereby approved and adopted effective and retroactive to January 1, 2024:


A. The following officials of the Village of Rushsylvania, Ohio shall receive the compensation indicated for the year 2023:

<u>POSITION</u>	<u>COMPENSATION</u>
1. President of Council (1)	\$42.00 PER MEETING
2. Councilmember (5)	\$40.00 PER MEETING
3. Mayor (1)	\$4,800.00 PER YEAR
4. Board of Public Affairs (2)	\$40.00 PER MEETING
5. President of Board of Public Affairs (1)	\$42.00 PER YEAR

B. WITHHOLDINGS/DEDUCTIONS. (i) Village Council and Board of Public Affairs: The Village shall withhold Federal Tax, Social Security, Medicare, State Tax, and Rushsylvania Income Tax. The Village will pay the employer share of Social Security and Medicare; (ii) Mayor: The Village shall withhold Federal Tax, Medicare, OPERS, State Tax, Rushsylvania Income Tax. The Village shall pay the employer share of OPERS and Medicare.

SECTION II: That this Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of the Village of Rushsylvania, Ohio, provide for its continuous uninterrupted services, and to authorize said compensation retroactive to January 1, 2024; and it shall, therefore, be in force and take effect immediately upon its passage and signature by the Mayor.
